### **III. LEGAL CONSEQUENCES OF AN UNTRUE STATEMENT**

The issuer of the statement acknowledges and agrees that, should this Statement be found to be untrue or incomplete, the Koprivnica Tourist Board is entitled to:

- reject the exhibitor's application and exclude the exhibitor from the further selection procedure for participants of the Renaissance Festival 2026;
- unilaterally terminate an already concluded Participation Agreement, with the right to collect a contractual penalty and damages in accordance with the General Terms and Conditions of Exhibiting;
- retain the paid deposit in full, as well as claim compensation for the actually sustained damage that exceeds the amount of the deposit;
- notify the competent authorities of the established untruthfulness in accordance with the applicable regulations.

### **IV. CONSENT FOR THE VERIFICATION OF STATEMENTS**

The issuer of the statement expressly authorises, and agrees, that the Koprivnica Tourist Board may, for the purpose of verifying the statements set out in this Statement, inspect its accounting records and request confirmation from the City of Koprivnica regarding the status of any debts of the exhibitor.

The processing of personal data is carried out in accordance with the General Data Protection Regulation (Regulation (EU) 2016/679 – GDPR) and the privacy information notice received by the issuer of the statement together with the application form (Annex 3 to the Public Call for Exhibitors).
